# Tree Removal on the Island

There has been some concern of late regarding the removal of mature and seemingly healthy trees on the Island - both from the Council owned nature strip and people's yards.

Two points need to be raised.

INFORMATION

1. Council tree removal rules

Private Property and Nature Strip - all trees over three (3) metres in height are protected under the Council's Tree Preservation Order, and a <u>Tree Works Application</u> is necessary for private property trees.

2. "Street tree planting is the coolest way to improve your neighbourhood" So says a recent article in the Central Coast Express Advocate April 19 2018 edition.

This article covered 3 quarters of the page including 4 photographs, so I will extract some sections that particularly apply to the increasing tree removal from St Huberts.

"... so much of our streetscape is becoming unbearably hot and unsightly ..."

"Increasing amounts of reflected heat from exposed road, cement and colorbond is creating a 'heat bowl' effect which is harmful to health."

"... the way to improve the economic and environmental value of a place is to increase its urban canopy."

"It is distressing that people in their ignorance cut down large established trees only to find that it's much hotter, that there is no shade to park under and that energy costs increase."

"Shade trees dramatically reduce temperature, glare and energy costs. They clean the air, reduce noise, absorb dust and improve biodiversity."

"Trees make all the difference, and it has been proven that this desirability is reflected in real estate value too."

"Global engineering and urban design company AECOM has analysed tree canopy coverage and five years of house price data across Sydney. The company found that houses on streets with 10 percent more tree coverage were worth an average of \$50,000 more than houses on less leafy streets in the same suburb."

And I personally am very pleased that Council lately have been repairing damaged kerb and guttering, rather than ripping the tree out.

Wisely they have been using hotmix bitumen for the repairs, which is more flexible and easily repaired or replaced [see the photo of a resident and her repair].

(And isn't the contrasting gutter so artistic.)

That's my 2¢ worth!

# **REVERSE VENDING MACHINES**

# A First Time User's Experience

# <u>returnandearn.org.au</u>

### First... some history and explanations

Over the past **40 years** (starting 1977) South Australia proved a Container Deposit Scheme worked to clean up the environment using a "polluter pays" approach. South Australia now has a **79.9% return rate**! After considerable obstruction

and naysaying from various organisations, the NSW government finally decided that it does work(!), and they put in place an initial clunky and hard to find system of (mainly) 2-container sized Reverse Vending Machines - 1 side for bottles, the other for cartons, plastic and cans. You put the recyclable container in a "black hole" and get a credit/voucher/donation choice in return.

Only certain containers result in a refund. Keep in mind this system was set up to reduce container littering, so only those sorts of containers are targeted. There is no refund on large containers such as wine bottles, cordial and milk bottles that are typically not thrown roadside. For consistency, the NSW scheme accepts and rejects the same containers as South Australia and the Northern Territory.

Manufacturers have increased the cost of an accepted container by at least 10 cents so we - the consumer - are actually paying the 10 cents to the RVM user. (It does appear that many items were increased up to 15 cents per container due to setup and maintenance costs incurred by the various industries running the scheme.) By this means, the beverage industry fund the entire scheme.

Most 150mL to three litre drink containers will be eligible for a 10 cent refund at an approved NSW collection point.

### Container materials that may be eligible for a refund include:

- Glass
  - Plastic
- Aluminium
- Steel
- Liquid paperboard (cartons)

Containers should be empty, uncrushed, unbroken and have the original label attached. Wine, spirits, cordial and plain milk containers are generally not eligible.

If a container isn't eligible for a refund, please use a recycling bin.

# Containers that can't be deposited for a refund include:

- Plain milk (or milk substitute) containers
- Flavoured milk containers of one litre or more
- Pure fruit or vegetable juice containers of one litre or more
- Glass containers for wine and spirits
- Casks (plastic bladders in boxes) for wine or water of one litre or more
- Sachets for wine of 250mL or more
- Containers for cordials and concentrated fruit/vegetable juices
- Registered health tonics

Initially the number of RVMs in NSW was very low and people had to travel 10s of kilometres to get to one, and then join a huge queue.

Currently, the closest RVM to Islanders is behind Cellarbrations on Ocean Beach Road Umina (linked to Woolworths) - hard to find, and unpleasant at night.





A full list of all sites that provide refunds is found at the <u>returnandearn.org.au</u> website. Thankfully more sites are being continually setup so there is more choice coming.

# **Refund Methods**

The RVMs have no cash involved in the refund. Instead there are three possible ways of obtaining or using your refund.

- 1. Digital Refund directly into your PayPal account you need one.
- 2. Retail Refund a printed voucher taken to a retail organisation for a cash refund or store credit.

3. Donate the refund to a charity or community organisations.



# Retail Refund

A machine needs a single "sponsor" - currently and typically Woolworths or Coles, who will provide the cash refund to you.

The refunding organisation is identified at the bottom of the "RETAIL REFUND" instructions on the RVM. Although... in trying to find the Cellarbrations RVM at Umina, the

Cellarbrations guys were quick to tell me they honoured the vouchers.

### Donation

To donate your refund you choose a charity or community organisation from a list on the RVMs screen.

The <u>returnandearn</u> website has the procedures required for your charity/ organisation to be added to this list.

• Digital Refund

Of course, these days, there is always the digital choice - in this case PayPal.

This system is painless, easy to use and very secure, but you do need to have a PayPal

**PayPal** account - a payment system owned by eBay, and tried, and proven as a common online payment method. The other component for a digital refund is a barcode that identifies the PayPal account the refund goes to.

Use your smart phone to download myTOMRA from your phone's App

Store

There is only one way to generate this barcode - you need to download the **myTOMRA** app for your mobile phone and register yourself as a RVM user.

The app creates your unique barcode that is scanned by the RVM when you are using it.

By the way, TOMRA and Cleanaway (our garbage collectors) are partners in the RVM system in NSW - TOMRA provides the machines and Cleanaway deals with the collected items.



Using myTOMRA to create or link myPayPal account, the app created a barcode which I scan from my phone at the RVM

# Using the RVM

There are simple instructions on the RVM once you decide where your refund goes - Digital, Retail or Donate. For a Digital refund, your first step is to scan your barcode at the top of your myTOMRA app on your phone. Scanning your barcode to start the whole process leads to slightly different payment screens - **PayPal** replaces **Voucher** as your payment choice. The **PayPal/Voucher** and **Donate** choice is made after you have entered all your containers.



At any and all stages, simply follow the instructions on the screen. After you have watched the person before you, and done it once yourself, it is a simple and easy process. Just start feeding in the items one at a time into the BLACK HOLE. Sometimes your hand goes in too far and the RVM wants you to insert again. The item is first checked that it has a correct barcode and not damaged then travels up the chute. Acceptable items show up in the appropriate part of screen as a number and another 10 cents added on.

# When finished...

**Digital** refund people hit the "PayPal" button to finalise the transfer of funds to their PayPal account, and PayPal emails you immediately with the transaction details.

**Voucher** people hit the "Voucher" button and retrieve their printed voucher from the slot to use at the correct retailer. **Donate** people hit the "Donate" button to bring up the list of possible organisations to select.

Then you put your plastic bags in the bins provided, and any cardboard taken back home for the Yellow lid bin!!

# Island Chef Recipe

This recipe is the first from another Island meat supremo - Ron Stapleton.

# Ron's Slow Cooked Lamb Necks

♦ Go to your local butcher ,"Mark Edwards" in Woy Woy, and ask for 4 whole lamb necks and have them trim some of the fat, split them down the middle, then cut into 3 (6 pieces per neck). Ask the boys if they can sell you some honey, mint and rosemary marinade or you can use mint jelly and fresh rosemary.

Cut 2 carrots, 2 sticks celery, 1 large onion all into approx 1 cm squares.

- Spread all the chopped veggies into a baking pan or casserole dish large enough to hold all the meat etc.
- Coat the necks with mint jelly or honey, mint and rosemary marinade and place bone down on top of the veggies. Chop some fresh rosemary and sprinkle over the lamb necks and salt and pepper to suit.
- 3. Whisk 2/3 tablespoons corn flour into 1 litre beef or vegetable stock and the lamb. Cover tightly with alfoil or casserole lid.
- Place in pre heated oven 180/200 degrees for 1 hour then 150/160 degrees for further 2 hours.
- 5. Take out of oven and check necks, should be soft and tender, easily coming off the bone.
- 6. Remove all necks onto another tray and thicken veggies more if needed and serve by placing the meat on a bed of vegetable or sweet potato mash and pour the veggies over the meat.

Lamb necks are the sweetest and most tender meat of all.

All images shot with the Nikon D500 and the Tokina 11-16mm f2.8 lens. I put the camera in Aperture mode and had the aperture set to between f6.3 and f8."



"... That way if we got a fairly close shot it wouldn't swamp the sensor. I set the ISO to 200 and the camera selected the appropriate shutter speed. You need a tripod and ... a remote if you have one. These was taken about 20 minutes

News junkies will have, Facebook users might have, but we all should have - been following the last few months of media coverage of how Facebook user data was "given" to a company who appeared to have tried to influence the last USA Presidential election. After the stuff had finish hitting the fan, Facebook decided they had better let their users know of all the data they had collected about YOU, the Facebook user.

Reportedly, after users discovered this concerning issue in the media, Facebook users didn't bother doing anything, or downloaded their Facebook data and then: were horrified and did nothing; changed settings on their Facebook page to combat some of this; or shut down their Facebook page.

# How to download your Facebook data

If you want to download exactly what Facebook knows about you based on your profile, there have been many articles written on how to do it. Being an Apple user I discovered this article in my travels through the Internet: <u>www.macworld.com/article/3265696/software-social/how-to-download-your-facebook-data.html</u>.

When you do eventually successfully download your data, you will end up with a mini-website in this downloaded folder. Open the *index.html* file inside the folder to open this mini website that shows you exactly what Facebook knows about you.

# Reduced Facility Charges for **Community Groups**

If you are part of a Community group in need of a venue for a purpose, this is for you...

Central Coast Council

Each year our local council publishes a list of fees and charges that can be found (buried) on the CCC website at gosford.nsw.gov.au (For the canal pontoons "owners", you will see your current annual pontoon/mooring fee on

Page 203.)

Of particular note this year was an amended (reduced) set of fees and charges for community and not-for-profit groups who wish to use Council facilities.

While SHIRA currently has no need to hire Council facilities for meetings or other purposes, members of the Island community and other readers of this newsletter may be involved with community groups who would benefit from these new charges.

The new charges are aimed at community groups who make less that 10 bookings of community facilities per year.

\*The minimum 3 hour booking requirement has been removed.

\*Hourly rate now reduced from a sliding \$20 to \$40 scale per hour, to a standard \$10 per hour.

The Council's aim is to encourage and increase patronage and diversity of use of Council's facilities.

Another community hall and centres fee change applies to regular groups who store items on site in either storerooms or storage cupboards. Previously charged \$3 to \$8 per week, this fee no longer exists.
